Subject: Opportunity to use Payroll Deduction to fulfill pledge to 2024 Diocesan Appeal

This memorandum is to provide information on pledge fulfillment for the annual appeal through payroll deductions from the Diocesan Central Payroll System.

If you would like to contribute to the Diocesan Appeal through a payroll deduction, by authorizing a deduction of a certain amount from each paycheck to your annual pledge, simply complete the form on the back of this letter. Please sign the form, and return it to your payroll administrator. This person will return it to the Diocesan Payroll Department. (Please note that you must receive your paycheck through the Diocesan Payroll system to be eligible for this payroll deduction option.)

Pledges of financial support are credited toward your registered parish's goal or a parish that you designate. Any gifts received that exceed the parish's goal are refunded to the parish.

When received, the payroll department will review the deduction option you choose and make any adjustments that might be necessary based on the frequency of your payroll. Pledges will be redeemed from the time the Office of Charitable Giving receives this information from the Payroll Department until the end of April 2025. You will receive an acknowledgment letter from our office with the pledge details. Please review it and contact me if there are any necessary changes.

The Diocesan Payroll Department will, at all times, maintain the strictest confidentiality regarding employee payroll information and will not share that information with anyone in our office.
